RECOMMENDING THE BOARD OF PUBLIC WORKS (BOARD):

1. APPROVE a Construction Order for the Kinney Street Improvements - Phase 1 Project (Project) to Jilk Heavy Construction, Inc., in the amount of \$3,197,490, with a not-to-exceed limit of \$3,517,239, including contingency.
2. AUTHORIZE the President or two members of the Board to execute the Construction Order after approval as-to-form has been obtained from the City Attorney.

DISCUSSION

Background

The Bureau of Engineering (BOE) administers the Emergency Pre-Qualified On-Call (PQOC) Geotechnical/Structural Contractors List (List) to provide urgent necessity and emergency geotechnical/structural construction services for repair, replacement, and/or construction of retaining walls, bulkheads, and slopes; placement of engineered fill and erosion control; debris removal and other emergency geotechnical/structural services on public works projects; and the preservation of public safety.

On December 13, 2023, the Board approved a list of six qualified contractors based on the evaluation criteria set forth in the Emergency PQOC List Request for Qualifications. The contracts were executed on December 13, 2023, with a term of five years, and they will expire on January 2, 2029.

Scope of Work

There is an urgent need to repair a portion of Kinney Street, located in a residential hillside area, approximately 1,750 linear feet northeast of the intersection of Kinney Street and El Rosa Drive in Glassell Park. Kinney Street is currently closed after portions of the street were undermined by a washout and the pavement settled in two locations on the street.

The washout affecting the north side of Kinney Street is in front of the property located at 3647 Kinney Street, approximately 8 feet east of the end of the curb and gutter and extending approximately 16 feet in width. There are other, smaller erosion gullies along the edge of Kinney Street, as well as other erosion areas further down the slope.

The area near the property located at 3655 Kinney Street is experiencing the most substantial settlement with a section of street pavement, approximately 2 feet wide and 40 feet in length, having settled more than one inch. This area has since been patched with asphalt, however, it still poses a localized loss of support for the street. The proposed Project will benefit the public by repairing the settlement, which is an immediate safety hazard, and will allow for the re-opening of Kinney Street.

The Project will construct two soldier pile walls, one on the upslope and another on the downslope side of Kinney Street, to restore lateral support for the roadway. The Project will also include drainage improvements, repairs to the asphalt concrete (AC) paving, replacement of the metal-beam guardrail, and placement of AC berms along the downslope side of the street to mitigate potential future erosion. The downslope retaining wall on the northern side of the street is approximately 215 feet in length, and the upslope retaining wall on the south side of the street is approximately 265 feet in length. Figure No. 1 is a Site Map of the proposed Project location, and Figure No. 2 is a photo of a retaining wall similar to the ones being proposed.

Due to the emergency nature of the work and the safety hazard posed by the washout and pavement settlement, a preliminary Construction Order was issued to Jilk Heavy Construction, Inc. on June 21, 2024, in an amount not to exceed \$500,000, which is within the City Engineer's authority, to quickly begin the procurement of construction materials that have long lead times.

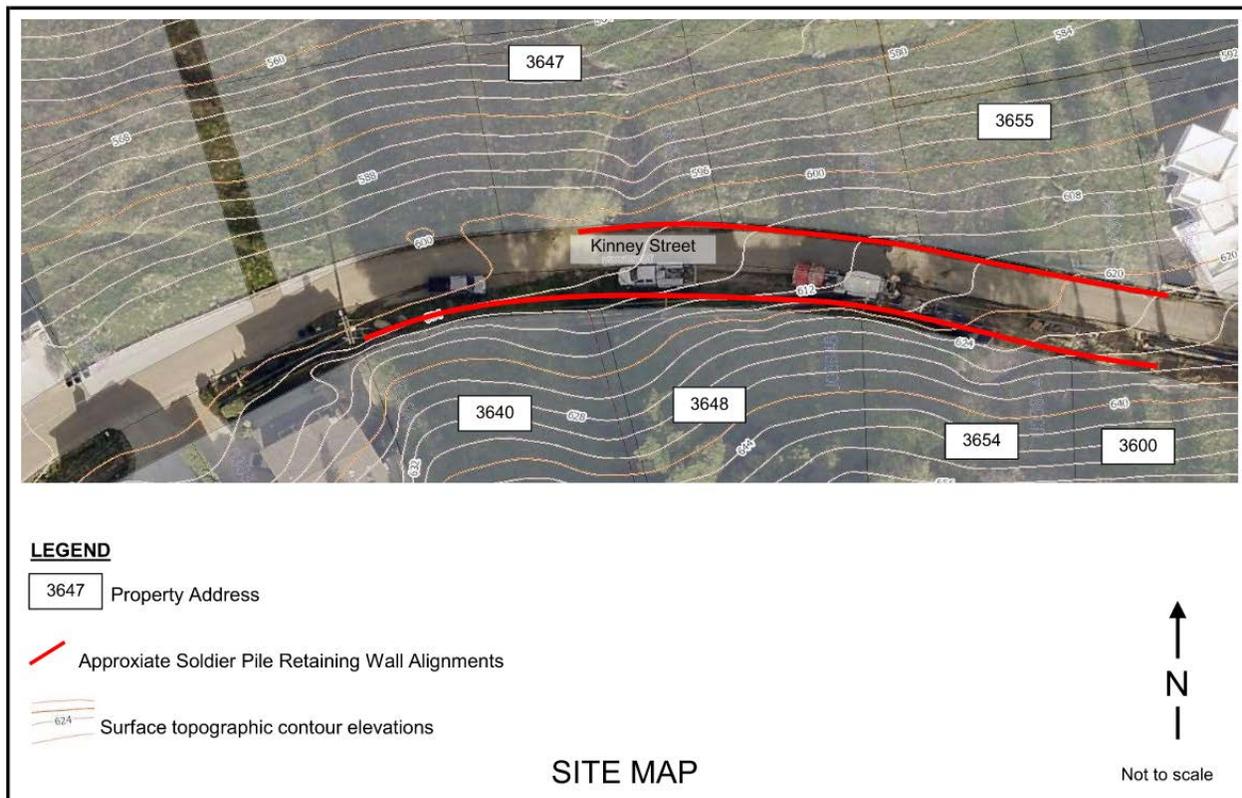


Figure No. 1 - Site Map

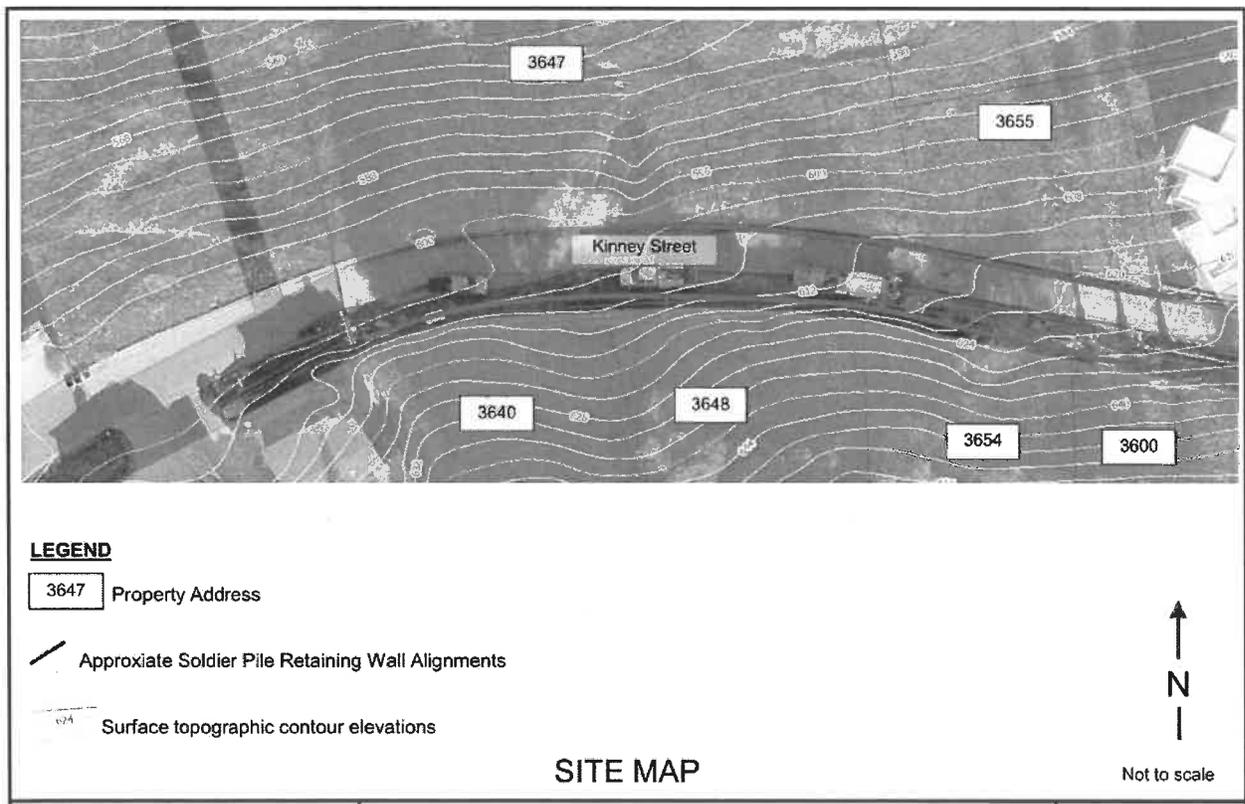


Figure No. 1 - Site Map

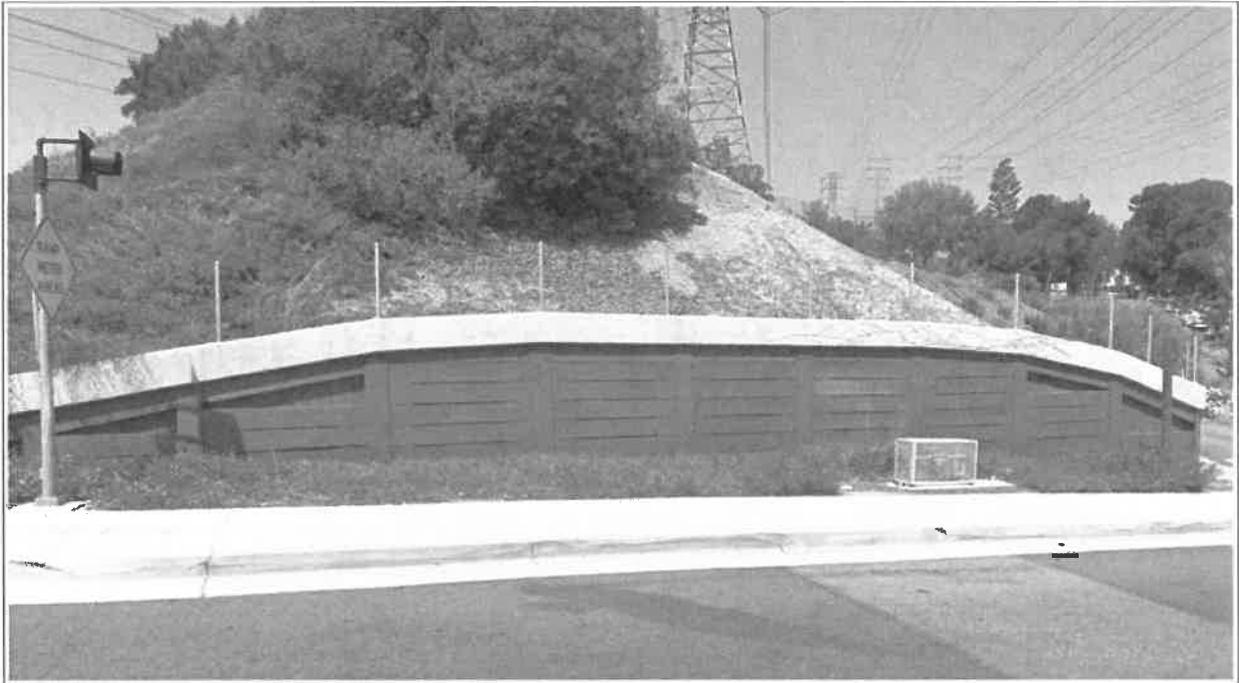


Figure No. 2 - Photo of Similar Constructed Bulkhead
