(PPC), first low bidder, to be the lowest responsive, responsible bidder, and AWARD PPC a contract for the Affordable Housing and Sustainable Communities (AHSC) Round 4 Jordan Downs S3 Sustainable Transportation Infrastructure (STI) and Transportation Related Amenities (TRA) Improvements (Project) for \$6,069,219.00.
2. AUTHORIZE the President or two members of the Board to execute the contract after approval as-to-form has been obtained from the City Attorney.

DISCUSSION

Background

The Project is a component of Phase 3 of the redevelopment of the Jordan Downs Public Housing Development. It is composed of a 92-unit housing development and STI/TRA improvements. The BOE will oversee the development of the STI/TRA improvements which include sidewalk/curb ramp replacements and upgrades, high-visibility crosswalks, bicycle boulevard treatments, increase in bus stop lighting, and upgrade from diesel to electric engine of a replacement LADOT DASH Transit bus. New street trees and crossing/traffic calming components are also proposed (Figure No. 1). The contract duration is 365 calendar days.

The Project has been reviewed for environmental considerations. It was determined to be categorically exempt pursuant to the provisions of the California Environmental Quality Act (CEQA) of 1970 under Article III of the City's CEQA Guidelines.

Axiom Group (Axiom), second low bidder, listed their Total Bid Amount incorrectly. Staff corrected Axiom's Total Bid Amount in accordance with the procedures set forth in the General Instructions and Information for Bidders. Axiom was contacted and notified of corrections. The corrections did not change the order of the bids.

PPC submitted page 1-4 (the "Signature Sheet and Affidavit") signed by its president and secretary; however, the signed page 1-4 was missing the required corresponding notarization. BOE staff contacted PPC regarding this issue, and PPC has since provided the notary sheet for both the president and secretary.

The BOE staff recommends that this clerical error be treated as a waivable defect, as an inconsequential or minor deviation, and that this error not affect the award eligibility/responsiveness. The BOE thus recommends that the Board waive this irregularity and deem PPC's bid to be valid, subject to verification of all other bidding requirements.

The Deputy City Attorney, Ms. Adena Hopenstand, has concurred with the recommendations contained in this report.

After evaluating the low bid and reviewing the unit costs, staff believe that this bid is acceptable given the tight grant deadlines the project needs to be constructed within, and the likelihood of not having additional bidders interested in this Project if it's re-advertised. The contract may be awarded to PPC subject to verification of all other bidding requirements.

Bid Withdrawal

In an interdepartmental correspondence dated November 11, 2024 and adopted by the Board on February 12, 2025 (Transmittal No. 2), the BOE acknowledged receiving Axiom's claim of clerical error in filling out their bid and recommended that Axiom be allowed to withdraw their bid with the understanding that, in accordance with the Public Contracting Code § 5103, the Board will not accept a bid from Axiom in the event the Project is re-advertised.

Local Business Preference (LBP) Program

Los Angeles Administrative Code Division 10, Chapter 1, Article 4, Section 10.25 adopted the LBP Program which was designed to increase local employment and expenditures in the local private sector. Businesses that qualify as a Local Business Enterprise (LBE) may be granted an eight percent reduction of their Bid amount solely for Bid evaluation purposes. If the LBE is also a Local Small Business (LSB) and/or Local Transitional Employer (LTE), they may be granted an additional two percent reduction for each of those certifications, up to a total of twelve percent. Businesses that qualify as a LBE, but neither as a LSB and/or a LTE, may be granted a one percent reduction, up to a maximum of two percent for each of those certifications, for every ten percent of their bid that is to be performed by a LSB and/or a LTE subcontractor. Additionally, all non-LBE Businesses may be granted a one percent reduction, up to a maximum of five percent, of their Bid amount solely for Bid evaluation purposes, for every ten percent of their bid that is to be performed by a LBE, LSB, and/or a LTE subcontractor.

For this Project, the Bureau of Contract Administration (BCA) verified that the first low bidder, PPC, is a certified LBE. However, this did not change the order of bids, and it did not affect the recommendation for award.

Business Inclusion Program (BIP)

On January 12, 2011, the Mayor issued Executive Directive No. 14 which created the BIP. This program provides MBE, WBE, SBE, EBE, DVBE, and OBE firms an equal opportunity to compete for and participate in City contracts. Additionally, the BIP requires bidders to perform and document BIP Outreach via the internet utilizing the Los Angeles Regional Alliance Marketplace for Procurement (RAMP) service.

The Project was advertised with anticipated participation levels of 4.00 percent MBE, 2.00 percent WBE, 25.00 percent SBE, 8.00 percent EBE, and 3.00 percent DVBE, and with mandatory BIP documentation requirements. Currently, the LGBTBE certification is not required as part of the BIP Outreach but is tracked for statistical purposes. The Office of Contract Compliance (OCC), based on a review of the documents submitted by PPC, reported that the contractor pledged participation levels of 0.00 percent MBE, 0.00 percent WBE, 8.65 percent SBE, 1.61 percent EBE, 0.00 percent DVBE, 0.00 percent LGBTBE, and 17.37 percent OBE, and complied with the BIP outreach requirements of the bid. The Mandatory Subcontracting Minimum requirement for this project is 25.00 percent and the contractor has complied by pledging a subcontractor participation level of 26.75 percent. This percentage was calculated after subtracting the fixed cost items of \$165,000.00 from the total bid amount.

Contractor Performance Evaluation

In accordance with Article 13, Chapter 1, Division 10, of the City of Los Angeles Administrative Code (L.A.A.C.), the Project Manager and the City Inspector for this construction contract shall submit Contractor Performance Evaluation Reports to the BCA (Department of Public Works) upon completion of this contract.

Peak Hour Construction and Right-of-Way Obstruction Regulations

All contractors must comply with the requirements specified in the Los Angeles Municipal Code Section 62.61 related to peak hour traffic restrictions unless an exemption from the Peak Traffic Hours Prohibition is approved.

Contractor Responsibility Ordinance

All contractors participating in this program are subject to compliance with the requirements specified in the City of Los Angeles Contractor Responsibility Ordinance

No. 173677 (Article 14, Chapter 1, Division 10, L.A.A.C.). Failure to comply with all the requirements specified in the ordinance may render this bidder's contract subject to termination pursuant to the conditions expressed therein.

Bid Bond Extension

PPC was requested to extend their Bid Bond which expired on January 28, 2025. The contractor has agreed to extend their Bid Bond until June 20, 2025.

Conclusion

In view of the above findings, staff recommends that the Board declare PPC, first low bidder, to be the lowest responsive, responsible bidder, and award PPC the contract for this project.

STATUS OF FUNDING

The Project is funded by the AHSC Grant Fund, which will be front funded by the Los Angeles Department of Transportation (LADOT) Transportation Grant Fund (TGF), as well as the Road Maintenance and Rehabilitation (SB1) Fund which has been approved in the 2025-2026 Budget.

As tabulated below, funding in the amount of \$1,877,668.89 will come from the TGF, Fund No. 655, Department No. 94, Appropriation Unit 94AT6G, and funding in the amount of \$5,101,933.12 will come from Road Maintenance and Rehabilitation (SB1) Fund which has been included in the FY 2025-2026 budget. The Fund, Department, and Appropriation Unit numbers will be identified at a later time.

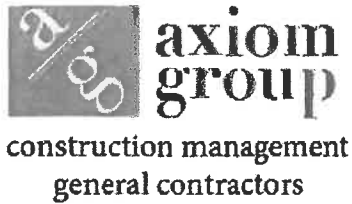

The Project was advertised with anticipated participation levels of 4.00 percent MBE, 2.00 percent WBE, 25.00 percent SBE, 8.00 percent EBE, and 3.00 percent DVBE, and with mandatory BIP documentation requirements. Currently, the LGBTBE certification is not required as part of the BIP Outreach but is tracked for statistical purposes. The Office of Contract Compliance (OCC), based on a review of the documents submitted by PPC, reported that the contractor pledged participation levels of 0.00 percent MBE, 0.00 percent WBE, 8.65 percent SBE, 1.61 percent EBE, 0.00 percent DVBE, 0.00 percent LGBTBE, and 17.37 percent OBE, and complied with the BIP outreach requirements of the bid. The Mandatory Subcontracting Minimum requirement for this project is 25.00 percent and the contractor has complied by pledging a subcontractor participation level of 26.75 percent. This percentage was calculated after subtracting the fixed cost items of \$165,000.00 from the total bid amount.

Bid Bond Extension

PPC was requested to extend their Bid Bond which expired on January 28, 2025. The contractor has agreed to extend their Bid Bond until June 20, 2025.

Conclusion

In view of the above findings, staff recommends that the Board declare PPC, first low bidder, to be the lowest responsive, responsible bidder, and award PPC the contract for this project.

STATUS OF FUNDING

The Project is funded by the AHSC Grant Fund, which will be front funded by the Los Angeles Department of Transportation (LADOT) Transportation Grant Fund (TGF), as well as the Road Maintenance and Rehabilitation (SB1) Fund which has been approved in the 2025-2026 Budget.

As tabulated below, funding in the amount of \$1,877,668.89 will come from the TGF, Fund No. 655, Department No. 94, Appropriation Unit 94AT6G, and funding in the amount of \$5,101,933.12 will come from Road Maintenance and Rehabilitation (SB1) Fund which has been included in the FY 2025-2026 budget. The Fund, Department, and Appropriation Unit numbers will be identified at a later time.




