The City of Los Angeles executed a contract with FilmL.A., Inc. (FilmLA) to:

1. Coordinate the film permit process in a centralized manner within the City;
2. Ensure that filming in the City is done in accordance with City ordinances and in a manner that minimizes interference with neighborhood and business districts;
3. Conduct community outreach and notification services to residential and commercial/industrial districts to inform them of filming within their communities; and,
4. Collect permit fees; develop and implement a marketing program to promote the City as a location for feature film, television and still photography.

FilmLA has provided these services since 2010 under two separate Contracts with the City. The City extended the term of the original Contract with FilmLA four times between 2010 and 2016. Subsequently, the City executed a new contract with FilmLA (Contract No. C-127625) in June 2016, for a four-year term with two (2) five-year renewal options. The Los Angeles City Council extended the first term of the contract for a period of six months to December 31, 2020, and later approved an amendment which authorized technical changes and extended the first term of the contract to March 30, 2021. FilmLA continues to work collaboratively with the City and act as liaison to the film industry;


The Los Angeles City Council exercised the first renewal option of the contract to extend the term of the contract to June 30, 2025. The City Contract Administrator, the Board of Public Works, is authorized to extend the term of this Contract for one (1) additional period of five years under the same terms and conditions.

Approval of this Motion shall exercise the second five-year renewal option to extend the term of this Contract from July 1, 2025 to and including June 30, 2030, unless terminated earlier in accordance with Section 7 of the contract. FilmLA will continue to work to centralize the issuance of film permits and will coordinate and improve actions for commercial filming and photography activities, and work with the Board of Public Works and necessary City departments to facilitate the issuance of filming permits for the City.

Due to the need for the Contractor's services to be provided expeditiously, Contractor may have provided services prior to the execution of this Motion and renewal option. To the extent that Contractor's services were performed in accordance with the terms and conditions of this Agreement, those services are hereby ratified.

I THEREFORE MOVE to exercise the five year renewal option to C-127625 beginning July 1, 2025, through June 30, 2030.


